# RISK ACKNOWLEDGEMENT & DISCLAIMER

## THIS IS AN IMPORTANT DOCUMENT: YOU MUST READ IT BEFORE SIGNING

- The Go Ape Treetop Adventure and Adventure+ course ('the Activity') is an aerial obstacle course where, once an instructor has attached a participant to the safety system, he or she cannot become detached. However, as with any physical activity there remains a degree of risk and the Activity can be physically, mentally and emotionally demanding.
- All participants must be a minimum height of 1m for Treetop Adventure and 1.2m for Treetop Adventure+ and weigh less than 130kg (20.5 stone)
  - One participating adult must accompany every two children under 6 years on the Treetop Adventure course.
  - Under 16s (children) aged 6 and over require a minimum of one adult per group of eight children to supervise them on the course or from the ground. In order to control behaviour supervisors must remain in visual contact of the children in their care for the duration of the Activity.
- I have carefully considered all of the risks involved in undertaking the Activity, including the risk of bumps, scrapes, cuts, bruises and other injuries and agree to undertake the Activity and/or give consent for the child(ren) listed below to participate in this Activity.
- I understand that Go Ape accepts no responsibility for loss, damage or injury caused by or during participation in the Activity, except where the loss, damage or injury was caused directly by Go Ape's negligence.
- I certify that I and any child(ren) (I am signing for, do not have any medical condition (including pregnancy) which might make it more likely that I/he/she/they be involved in an incident which could result in injury to myself/him/her/themselves or others.  
If in doubt, (please check with the child's parent or guardian).
- I confirm that if I am not the parent/legal guardian of the child(ren) I have authority from the child(ren)'s parent or guardian to sign this consent form.
- I confirm that I am not under the adverse influence of drink or drugs.

**I have explained to the child(ren) listed the importance of listening to the instructors and following the rules and procedures set down by Go Ape. I have also made it clear to the child(ren) that they should not start the Activity unless they understand all instructions given. I confirm we have read the Safety Rules.**
