## RISK ACKNOWLEDGEMENT & DISCLAIMER

## THIS IS AN IMPORTANT DOCUMENT: YOU MUST READ IT BEFORE SIGNING

- 1. I am 16+ years old and wish to undertake the Forest Segway Activity ("the Activity") organised by Go Ape.
- 2. If assuming responsibility for any under 16 year olds, to accompany and supervise, I declare that I am aged 18 years or older. I declare that if I am not the child(ren)'s parent or guardian I have the authority of the parent or guardian to sign this risk acknowledgement and disclaimer.
- 3. I and the children in my care each weigh between 7 and 18.4 stone or 45 to 117kg as is necessary to operate the Segway safely.
- 4. I agree that I am responsible for my own safety and that of any under 16 year olds that I have signed responsibility for below and I undertake to ensure that he/she/they read, understand and will follow the instructions set out in the Safety Rules and verbal instructions mentioned above. If having completed my training, I am unhappy to accept this level of personal responsibility, I acknowledge that I can return to the site cabin for a full refund
- 5. I understand that riding a Segway in a forest environment has a significant potential for serious injury and that it is necessary to maintain control of the Segway at all times.
- 6. I understand that a helmet is provided for my safety and I agree to wear the helmet and have it fastened at all times when operating the Segway.
- 7. To reduce the risks I agree to follow the Safety Rules that I have received with this document as well as all the instruction to be given to me by instructors before undertaking the Activity.
- 8. I am voluntarily participating in this Activity with the knowledge of the dangers involved and I agree to accept any and all risks of loss, injury, or death. In the event of an accident or any damage, loss, injury or death I acknowledge that Go Ape will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the Activities (except for death or personal injury caused by Go Ape's negligence) and I waive all and any claims against Go Ape in this respect both for myself and for the children in my care.
- 9. I agree immediately to cease operation of the Segway if I am concerned in any way about its operation.
- 10. I certify that to the best of my knowledge neither I nor any children in my care have a medical condition which might make me or him/her/them more likely to sustain an injury. To the best of my knowledge I and any children in my care are not pregnant.
- 11. I confirm that I am not under the adverse influence of drink or drugs.

I acknowledge that I and the child(ren) in my care (if applicable) have received, read and understood a copy/copies of the Safety Rules in relation to the Activity.
