RISK ACKNOWLEDGEMENT & DISCLAIMER

THIS IS AN IMPORTANT DOCUMENT: YOU MUST READ IT BEFORE SIGNING

If over 18 you can supervise under 16 year olds ("children"). 16 and 17 year olds can ride unsupervised.

- 1. I wish to hire (a) bicycle(s) including all accessories and attachments supplied ("the Bicycle(s)") from Adventure Forest Limited ("the Company"). I am aged 16+.
- 2. I declare that I am the parent or guardian of any child(ren) that I will be supervising, or that I have authority from the child(ren)'s parent guardian to sign this risk acknowledgement and disclaimer. I agree that I am responsible for the child(ren) in my care and am aged 18+.
- 3. I agree that I and any children in my care will undertake the Bicycle Hire ("the Activities") in accordance with the Terms and Conditions of this document together with the oral instructions and advice to be given to me before undertaking the Activities.
- 4. I confirm that I/we have been encouraged to wear a safety helmet, which is available free of charge with the Bicycle(s). In addition, I agree to ensure that any child(ren) I am supervising wear(s) their safety helmet at all times when they are undertaking the Activities.
- 5. I understand that the Company has agreed to provide me with (a) bicycle(s) in good working order and I confirm that I have tested and checked that this is the case prior to the start of the hire period. In the event of a breakdown of the Bicycle(s) during the hire period I undertake not to attempt any repairs or adjustments but will ensure that the use of the Bicycle is ceased immediately and it/they is/are returned to the Company.
- 6. I confirm that I and all other persons using the Bicycle(s) has/have the necessary experience and competence to ride it/them safely and will ride them in a manner within our competence. I acknowledge that I am responsible for my own safety (and the safety of my possessions) whilst undertaking the Activities and have agreed to undertake the Activities without a Guide.
- 7. I undertake that the Bicycle(s) will not be used improperly and that it/they will be returned to the Company in the same condition as they were received (save for ordinary wear and tear) at the place, date and time agreed by the Company and the Hirer. I agree to indemnify the Company in respect of all loss, costs, claims, expenses and demands arising out of the use of the Bicycle(s) during the period of hire, howspeyer caused
- 8. In the unlikely event of an accident, or loss or damage to my personal effects to myself or the children in my care, I acknowledge that the Company will not be liable for any direct or indirect loss, damage or injury arising from or in connection with the Activities (except for death or personal injury caused by the Company's negligence) and I waive all and any claims against the Company in this respect both for myself and/or for the children in my care.
- 9. I certify that to the best of my knowledge neither I nor any children in my care have a medical condition (including pregnancy) which might have the effect of making it more likely that I/they be involved in an incident which could result in injury to myself or others. (If in doubt please check with the child's parent or guardian).
